#### **Chairman's Corner**

Over the last several months, the Board has been very involved with responding to the Joint Legislative Program Evaluation Oversight Committee. The December report recommended further review of and possible elimination of the Board. On Wednesday, January 21, the Board was a given an opportunity to address the Joint Legislative Program Evaluation Oversight Committee in Raleigh during their meeting. Our allotted time was brief and we presented our arguments to retain the Board in the current independent form. The Division referred the Program Evaluation Division's report and our response to the Legislative Oversight Committee. This December report had recommended further review of and possible elimination of the Board. Overall, the day went well. We spoke to several Senators and Representatives. Senator Stan Bingham expressed support for the Board and Registered Foresters in general during his open remarks. Pryor Gibson of NCFA and his staff were very helpful in securing the opportunity for the Board to speak, which was only given to several Boards. We appreciate these kind words and actions. Several Registered Foresters and landowners wrote letters of support which were made part of the meeting's public record. There may not be immediate action by the legislature. but we will stay abreast of any threats.
